NOTICE TO TRIALERS

It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer or any participant at an event held under these rules in not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such actions as it deems fit on receipt of a report indicating that this has occurred.

Judges shall have the power to disqualify any dog which shall not appear within fifteen minutes of the time designated for its turn to be tried, and to turn out of the stake any dog which does not obey its handler or any dog which they consider unfit to compete. Bitches in season may not compete and must be withdrawn. The entry fees of all such dogs shall be forfeited except in the case of bitches in season.

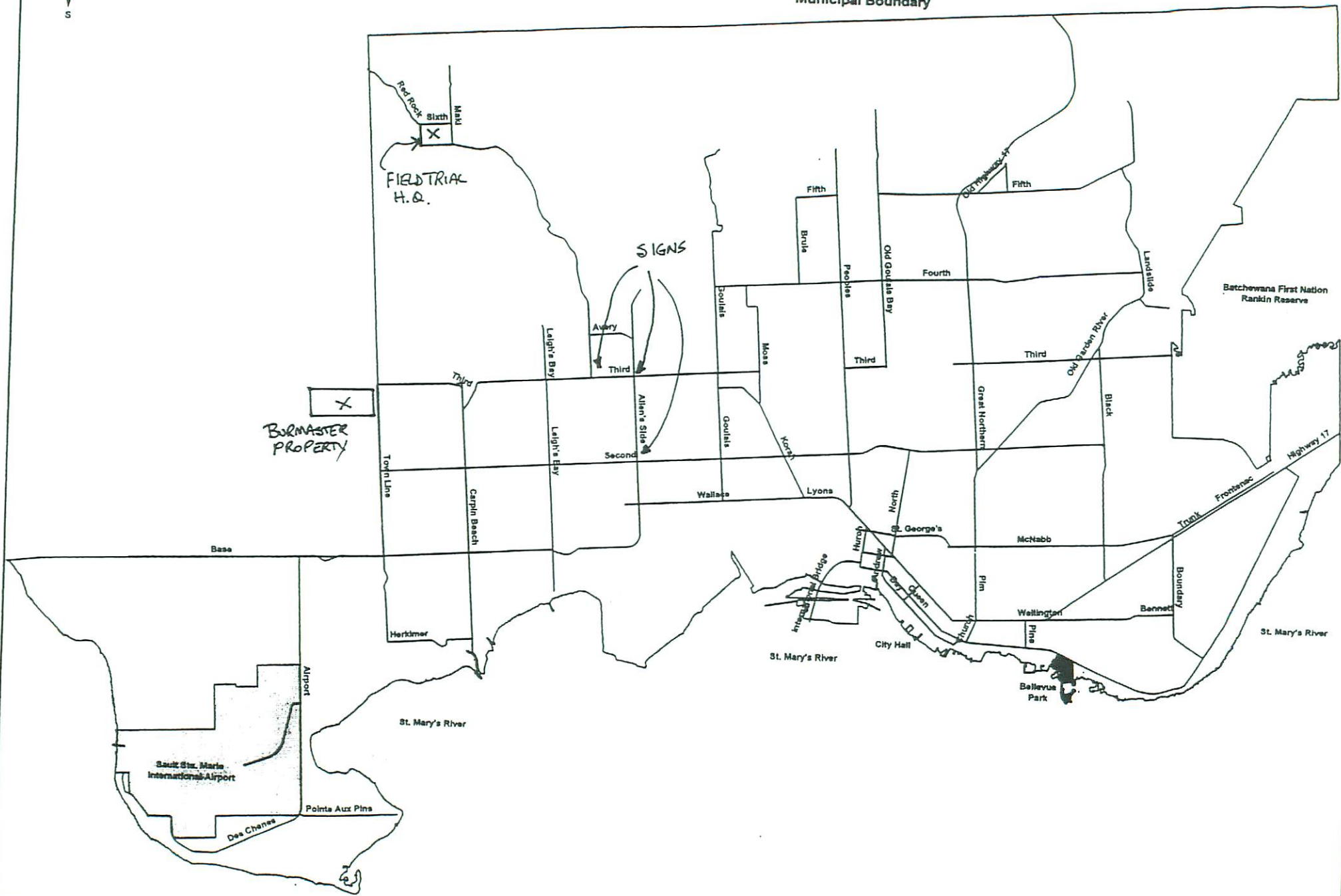
